Formation of Cauvery North Wild Life Sanctuary in Hosur and Dharmapuri Forest Divisions under the Wild Life Protection Act.

[G.O. Ms. No. 30, Environment and Forest (FR V), 24th February 2014, மாசி 12, விஜய, திருவள்ளூர் ஆண்டு 2045.]

No.II(2)/EF/254/2014.—In exercise of the powers conferred by clause (b) of sub-section (1) of Section 26-A of the Wild Life (Protection) Act, 1972 (Central Act 53 of 1972), the Governor of Tamil Nadu having considered that the area declared as reserved forests under the Tamil Nadu Forest Act, 1882 (Tamil Nadu Act V of 1882), the boundaries of which are specified in the Schedule below, is of Adequate ecological, faunal, floral, Geo-morphological Natural and zoological significance hereby declares that the areas specified in the schedule below, shall be a sanctuary for the purpose of protecting, propagating and developing Wild Life and its environment with effect on and from 24-2-2014 and shall be called as a *Cauvery North Wild Life Sanctuary*.

BOUNDARIES

North.- Starting from the eastern boundary of Thalli extension reserved forest at a cairn on Karnataka border at karadikuttai rock, the boundary line runs at a bearing of 210 degrees for 498 links to carin No.2; thence, with a bearing of 198 degrees for 1060 links to cairn No.3 at Upper Bundai; thence, with a bearing of 209 degrees for 370 links to carin No. 4; thence, with a bearing of 197 degrees for 1207 links to carin No.5 at Virasandiram Guttai; thence, with a bearing of 196 degrees for 1668 links to carin No.6; thence, with a bearing of 195 degrees for 640 links to carin No.7 at Karienpalayam Guttai; thence, with a bearing of 214 degrees 1395 links to carin No.8 at Thesathalliaggu; thence, with a bearing of 195.5 degrees for 1588 links to carin No.9 on Neria Alamara; thence, with a bearing of 190.5 degrees for 1684 links to cairn No.10 Karikal Ani.

The boundary then continues along the eastern boundary of Thalli reserved forest from Kuntana Gudde southwards up to Karadikal Gudde, then to Hurulibidu gudde, then to Kemgala gudden then excluding the cultivation of Ganganahalli to Muneswaranabetta and Devarabetta; crossing the cultivation on the east of the deserted Village of Hosatti; then from Devarabetta southwards to Adivikerai; then to basuvanahallikerai Bande; then westwards along the path from Thalli to Marasundaram and Gunur Bagarikan Kunte; and then southwards to Uppuhako Bande and Mariappana Hunisemarada Kallu and down to Devarajanakerai along the path from Achubalu to Belalam.

From the above Kerai the line runs along the path from Achubalu to Belalam up to Belalam cultivation; then skirting the cultivation to Pagadinatha-Thaganathakallu, then on to Baimum Alamara, and then to Rayapana Holatha Alamara; then to the path from Belalam to Terubide Village in Karnataka; then along the above path to Karnataka boundary.

After a break along the Karnataka border beginning at the point where the boundary of the Southern tip of Thalli reserved forest meets the Karnataka border, up to the point where the Northern tip of Jawalagiri reserved forest meets the Karnataka border, the boundary line continues along the northern boundary of Jawalagiri reserved forest. The line follows along the southern cultivation of Kempathalli Village up to the junction of Kempathalli and Nellumaru Agraharam boundaries at Mannuguddai, thence, a demarcated line north eastwards along the Agraharam boundary for about one mile, and then turning south east along Vetturpalayam cultivation over Dasaruhalla Bayilu and Azzibayilu Salamara to Vettrupalayam Nelu Bavi Guddai, thence, on to the path from Vettrupalayam to Javalagiri, then along the path as far as Melepuruvathavadi Mola Hola Alamara, then across to Gidikavandanagundu on the path from Melepuruvathavadi to Hrasankal.

From the last point, a demarcated line runs southwards along the Javalagiri cultivation to Javalagiri Muthirayan Gudi then turns east wards to Ponnammiguddai, and then to Belapatana Sheruvu Guddai (at the east of the path from Javalagiri to Sulekunta); thence, on the Yelachangavundanakerai, thence, along the path from the Kerai to Buranahalli and along the cultivation of Buranhalli to Munigudi Bandai then across to Kulavaguddai, then across to Karikal Bandai, and then across to Thinna Karaikal Yeni Bandai to Nachi Halli Gerai Maratha Bandai, then along Nachihalli cultivation to Sittithappana Bandai and then across Basuvana Bandai and Sanyasi Muni Alamarada Bandai to Kothikal Bandai.

The boundary then continues along the Northern boundary of Panai reserved forest. Starting from cairn No. 1 situated on the eastern boundary of Gulhatti reserved forest, 11482 links south of its north-east corner, the line runs along the northern boundary of Aiyur Extension II reserved forest with a bearing eastwards $69\frac{1}{2}$ for 114 links to cairn No. 2 at the south-west corner of survey Number 362 of Bettamugalalam; thence, along the south side of that field for 206 links to cairn No. 3; thence, along the same boundary of the said field No. 375 links to cairn No. 4 at its south-east corner; thence, with a bearing of 101 for 133 links to cairn No. 5; thence, with a bearing of $99\frac{1}{2}$ for 446 links to cairn No. 6; thence, with a bearing of 18 for 406 links to cairn No. 7; thence, with a bearing of 9 for 546 links to cairn No. 8.

Thence, it follows the northern and western boundaries of Aiyur Extension III reserved forest as shown below:—

Thence, the line runs along the western boundary of Aiyur Extension reserved forest, north by east and north by west along the western boundary of Survey Number 174 past cairns Nos. 65 to 69 to cairn No. 70 at the junction stone of Survey Numbers 174, 152 and 91; thence, north-north-east for about $12\frac{1}{2}$ chains to cairn No. 71; thence, north-north-east for about 6 chains to cairn No. 72; thence, in the same direction for about $17\frac{1}{2}$ chains past cairn Nos. 73 to 77 to cairn No. 78 on the right bank of the Thabagulivanka stream where the path from Arasajjur to Kuchuvadi crosses the stream; thence, generally northwards along the right bank of the said stream to cairn No. 79 on the northern boundary of Survey Number 152; thence, generally west-north- west along the northern boundaries of Survey Numbers 152 and 144 past cairns numbers 80 to 82 to cairn No. 83 situated at the north-west corner of Survey Number 144; thence, northwards and north-westwards for $27\frac{1}{2}$ chains past cairns Nos. 84 and 85 to cairn No. 86 at the south-east

Thence, along Aiyur Extension reserved forest northern boundary, starting from cairn No. 1 at stone No. 80 at S. No. 343 to 345 of 29 Santanapalli Village, the line runs generally east along the northern boundary of that village past cairns Nos. 2 to 11 to cairn number 12 at the south-west corner of Survey Number 173 of Ratnagiri village; thence, the line runs east and then generally east by north along the southern boundaries of Survey Numbers 173, 125 and 102 past cairns Nos. 13 to 20 to cairn No. 21 and the south-east corner of Survey Number 102; thence, north-east for about 38 chains past cairns Nos. 22 to 25 to cairn No. 26 on a high rock; thence, east by north past the south-east corner of Survey Number 186 for about 20 chains to cairn No. 27; thence, north-east for about 20 chains to cairn Nos. 156 of Marandahalli Extension Reserve at the southern most corner of Survey Number 86 (all the survey fields mentioned above appertain to the Ratnagiri Village).

Thence, north by west for about $8\frac{1}{2}$ chains to cairn No. 238; thence, east-north-east for about $8\frac{1}{2}$ chains to cairn No. 239; thence, generally with the same direction for about 21 chains to cairn No. 242 past cairn Nos. 240 and 241; thence, east by north for about 2 chains to cairn No. 243; thence, north-by-east for about 20 chains to cairn No. 248 past cairns Nos. 244 to 247; thence, generally west-north-west for about 32 chains past cairn No. 249 to 251 to cairn No. 252; thus excluding Ratnagiri hill which lies between this cairn and cairn No. 238. Thence, north-north-west for about $8\frac{1}{2}$ chains to cairn No. 253; thence, north-north-west for about 29 chains to cairn No. 254; thence, north-north-east for about 16 chains to cairn No. 255; thence, north-north-west for about 18 chains to cairn No. 256; thence, north for about 7 chains to cairn No. 257; thence, north for about $4\frac{1}{2}$ chains to the starting point of the northern boundary of Udedurgam reserved forest.

Thence, along the northern boundary of Udedurgam reserve forest, starting from cairn No. 1 at the south-west corner of Survey Number 968 of 27 Pachchappanatti, the line runs east-north-east along the southern boundary of Survey Number 968 for about 19 chains to cairn No.2; thence, east-north-east for about 15 chains to cairn No.3; thence, in the same direction for about $3\frac{1}{2}$ chains to cairn No.4; thence, east for about 2 chains to cairn No.5 on the right bank of the Chinnar river; thence, along the southern boundary of Survey Number 968 east-north-east for about $5\frac{1}{2}$ chains across the river to cairn No.6; thence, along

Thence, the line runs north-west by west along the southern boundary of Udedurgam reserved forest for about 12 chains to cairn No. 188 at stone No. 127 of Survey Number 141 of Panchapali Village passing stone No. 128 of the same field; thence, north-west for about 38 chains to cairn No. 190 on Makerdonaikal past cairn No. 189; thence, west-south-west for about 10 chains to cairn No. 191 at the north-east corner of Survey Number 232; thence, along the northern boundaries of Survey Numbers 232, 231 and 230 to cairn No. 195 and the north-west corner of Survey Number 230 past cairn Nos. 192 to 194; thence, along the eastern boundary of Survey Number 229 to cairn No. 196 at the south-east corner of that field (the Survey Numbers all appertaining to Panchapalli village); thence, across the Chinnar to cairn No. 197 on the northern side of the path from Panchapalli to Sadanapalli opposite to cairn No. 2 of Marandahalli Extension, then generally north-west along north side of the path from Panchapalli to Chinandanapalli to cairn No.1 of Marandahalli Extension.

Thence, along the northern boundary of Marandahalli extension reserved forest starting from cairn No. 1 at a point on northern Margin of a footpath from Chinnasadanapalli to Panchapalli about 30 chains north-east of the place where the said path enters Survey Number 68 of Ratnagiri, the line runs along the northern margin of the path generally eastwards to cairn No.2 about 3 chains north-west of the northern corner of Survey Number 227 of 81 Panchapalli, leaving the Udedurgam reserve at this point.

Thence, south (north point) for about 3 chains to a rock marked as cairn No. 36; thence, south for about $7\frac{1}{2}$ chains past cairn No. 37 to cairn No. 38; thence, south by west for about $3\frac{1}{4}$ chains to cairn No. 40 at stone No. 56 of that Survey Number; thence, south for about 6 chains to cairn No. 41;

thence, east-south-east for about $1\frac{1}{2}$ chains to cairn No. 42 at stone No. 57 of Survey Number 81 of Panchapalli; thence, along the common boundary of Panchapalli and Bettamagalalam villages past cairn Nos. 43 to 48 to cairn No. 49 and the trijunction stone of Panchapalli, Bettamagalalam and Periyatur; thence, south by east for about 4 chains to cairn No. 50; thence, south-south-east for about $3\frac{1}{2}$ chains to cairn No. 51 on top of a big rock; thence, in the same direction for about $3\frac{1}{4}$ chains to cairn No. 52; thence, south-east for about $7\frac{1}{2}$ chains to cairn No. 53; thence, south for about $3\frac{1}{2}$ chains to cairn No. 54 at stone No.4 of Survey Number 52 of 82 Periyatur; thence, along the common boundary of Periyatur and Bettamugalalam and Marandahalli Mitta in the Dharmapuri Taluk; thence, along the common boundary of Bettamugalalam and Dharmapuri Taluk at cairn Nos. 72 to 114 to cairn No. 93 of Marandahalli reserve No. 30.

on Kilathiddu saddle which point is the north-east corner of the Tholuvabetta Extension reserved forest Number 205.

Thence, the line runs southwards along the eastern boundary of Tholuvabetta extension reserved forest along the taluk boundary, i.e., along the west boundaries of the Tirumalavadi Mitta and Kesaraguli and Morappur reserved forests Nos. 95 and 36 respectively up to the cairn at the north-east corner to Gutirayen reserved forest No. 35.

Thence, the boundary runs through Gutirayen reserved forest along the taluk boundary and it follows the boundary till the trijunction of the taluk boundary, north-eastern tip of Biligundlu reserved forest and south-east tip of Kempakerai reserved forest.
